Greetings from Sal Ferreras, Vice President, Education and Student Services, VCC

Dr. Ferreras noted that VCC's new strategic plan has been launched, and that a large transformation is taking place at VCC. The four main areas that VCC is focusing on are as follows:

- 1. Student access/student success
- 2. Partnerships & collaboration
- 3. Operational efficiencies
- 4. Building the VCC brand.

Over the next ten years, VCC will experience an increasingly diverse student population, ranging in age from teens to middle aged. Persons with disabilities will comprise a large segment of the student population. It will be a challenge to address the needs of students with disabilities from the viewpoint of both teaching and support services.

Dr. Ferreras also mentioned that libraries have an important role to play in the social life of the student, particularly in an institution like VCC where students are quite transient. Students have the desire to be part of a learning community.

4.0 Business arising from the Minutes of April 6, 2011

- **4.1** Website Update Sybil Harrison Sybil has sent out passwords for the Springshare site. CPSLD minutes will appear on the public website once they are approved. A private area will be created on the website.
- **4.2** Compiled CPSLD Annual Statistics: 2001-2010 Todd Mundle Todd Mundle loaded the statistical summary into the new website, in both Excel and PDF formats.

- Write Away Update Todd Mundle bcCampus and Irving Barber Centre have provided funding for a pilot project. WriteAway is a shared service that is based on the AskAway (BCELN) collaborative service model. Sunni will help support the project then Sunni's time will be back-filled. Debbie Schachter and Shahida Rashid sit on the WriteAway committee. The pilot will run in winter 2012.

4.7 Assistance to Aboriginal Learners through IAHLA – Todd Mundle UBC Kelowna Campus is helping aboriginal students qualify for admission. Developing a program to improve admissions and success rates.

KW has a liaison librarian who visits the Aboriginal Centre 2 hours @ week.

SFU – push towards creating courses to support First Nations students. Gave community borrower cards to the Native Education Program. It was noted that all post secondary institutions have service plans in place to support and retain First Nations students.

5.0 New Business, Reports and Updates Part 1

5.1 Statistics – observations, review and relevance – Kim Isaac Korinna Luk was thanked for her excellent work on compiling the annual statistical report.

The Statistics Committee incorporated member feedback into revised definitions, although some were 'parked' for further discussion. New definitions will be distributed in Spring 2012.

Comments centred around two main categories: 1. Collections and expenditures (i.e. absence of questions relating to digital collections (ejournals, databases, streaming media, and e-books), and emerging technology trends. For example, CARL has an emerging services category. We could collect information about specific areas of interest only for a short time.

It was noted that both CARL and COPPUL collect statistics about ejournals, but not about streamed collections.

It was suggested that CPSLD stat collection procedures should be in line with other consortia.

Debbie described the new AVED ministry structure. She reports to the Deputy Minister of the Quality Inspection Branch. International education – new branch. Quality Assurance Branch oversees agencies such as BCELN.

7.1 BCLA Membership Drive – Todd Mundle Discussion about promoting BCLA. Noted that Educational Institute contains valuable continuing education and that we should encourage our staff to be involved.

7.3 Future meeting dates/places

Discussion that we might attach our Spring 2012 meeting to BLCA (Richmond). Possible date of 1-day meeting could be May 9, 2012. There is also interest to host from Okanagan College and Quest University Canada and Northwest has explored Haida Gwaii possibilities.

New libraries at Thompson Rivers University and Vancouver Island University (Duncan Campus) could be explored.
