3.2 Treasurer's Report [D. Gullacher]

Gwen proposed a possible alternative model – UBC/UVIC/SFU worked together to bring an established trainer (DeEtta Jones) to bring the library management skills to our region – also offered virtual training – possible greater impact and use some of CPSLD funds to support that?

3.5 Open Education Resources and Collaboration [C.
